General Service Office • September 2020: Greg T, General Service Manager. "Some further context — when literature sales and contributions had dipped dramatically, GSO drew down \$3 million from the Reserve Fund to cover cash flow for May-July. This supported sending out International Convention refunds, as well as ensuring payroll funds for our workers. Now we are in a different place. And it says so much about our Fellowship in this extraordinary time: In May, contributions were \$800,000 and in June \$900,000. July has just closed, with total contributions exceeding \$1.1 million dollars! Also, we are working to recover lost costs related to the International Convention through our insurance claim." • On-line contributions: "Our hope is to provide the most accessible and streamlined experience possible on all web-ready devices, including the ability to contribute without registering for an account and to receive instant email acknowledgments. For members who choose to register an account, both their contribution and webstore details will be available in one unified view.
