- -Al-Anon room mildewed floor / carpet (believed could possibly affect the health of those in the building adversely due to the severity). Total coast for repairs (labor / materials) \$2,810.59. Al-Anon has already raised \$2,000 through donations. Requesting that Atascocita AA donate \$1,010.59 to complete repairs to the Al-Anon room, as well as to complete the repairs in the kitchen.
- -Travis requested info regarding warranty for this project (correction: warranty would be on the flooring, not the labor)
- -Jim advised the Atascocita AA Group has that amount in the Available Funds, but is due to be sent to GSO.
- -Donna motioned to put the available funds toward the building and bypass GSO this month. Barbara seconded the motion. Cheryl briefly mentioned a compromise.
- -Vote was taken to allocate the amount of \$1,010.59 for repairs t no building (Al-anon room and kitchen ceiling), and passed, minority opinion was heard, no one changed their vote.
- -Jim motioned to donate \$500 to GSO from Prudent Reserves. Catherine seconded the motion. This was voted on and did not pass. (Concerns discussed should always send money to GSO, should worry more about sending money to GSO than being able to spend money on Anniversary party, should take care of home group before taking care of other AA service entities).
